Ronald V. Stehman has been involved for over 40 years with engineering, construction, development, codes enforcement and fire safety for various types of buildings. Ronald was the State Fire Authority for the Pennsylvania Department of Labor & Industry for Nursing Homes and Hospital building construction approval for Federal Reimbursement Certification, Staff Consultant with the Hospital Association of Pennsylvania, Special Assistant to Secretary of Pennsylvania Department of Health, Executive Director of Plant Engineering & Construction for Tressler Lutheran Services Associates, Inc. and Vice-President for Engineering and Construction for Lutheran Social Services – South Region and Vice – President Barmar Corporation.

Ronald's areas of specialization include the following: Retirement Community Development Planning, Construction Management, Building Construction & Fire Safety Consultant Services and Risk Management

Ronald was actively involved in consulting with private and non-profit health care facilities and the Federal Government. Consultant services included fire safety, development and construction supervision for retirement communities and major housing projects for retirement living. He was instrumental in developing 25 retirement communities. Ronald's broad experience in development, construction supervision and governmental service made him uniquely qualified in the development of retirement communities.

Ronald personally developed, staffed and managed both Pennsylvania

Department of Labor & Industry and Pennsylvania Department of Health divisions for the Enforcement of Building/ Safety Regulation and Construction Plan Approval governing health care facilities/housing design and construction. Ronald chaired the Fire Marshall's Committee representing 6 states in the previous Federal Department of Health, Education & Welfare, region III, Philadelphia, Pennsylvania. Ronald appeared on the Philadelphia television, Channel 6, WPVI, Program "Focus", "Health Facilities Fire Safety." Ronald was the invited speaker at four Pennsylvania Association of Non Profit Homes for Aged Annual Meeting. Ronald was a recognized authority on Fire Safety throughout Pennsylvania, and continued to be involved in promoting Fire Safety throughout Pennsylvania and promoting Fire Safety in Nursing Homes and Retirement Communities.

Ronald was a Certified Real Estate Salesperson with the Commonwealth of Pennsylvania Department of State, Bureau of Professional & Occupational Affairs. He was very active in community affairs.
